MINUTES OF MEETING HELD ON WEDNESDAY 19TH SEPTEMBER 2012 IN LENZIE PUBLIC HALL

1.0 ATTENDANCE

2.0 APOLOGIES

Ron Hall (Post meeting note – there was uncertainty at the previous meeting concerning the number present for the meeting to be quorate. The model scheme states this as ‘at least one-third of its total number of members’. In our case at the present time, that corresponds to four members.)

3.0 POLICE REPORT

PC Elaine Fraser attended, representing Community Police. Crime statistics for the last 3 months were presented in terms of percentage increase or decrease. This was thought to be less informative than the former practice of giving actual figures. In discussion it emerged that the Community Police webpage has been changed so that only percentages are now provided. It was agreed to bring this to the attention of the Community Policing management. There was discussion on speeding offences which had increased substantially, although this was thought to reflect more energetic enforcement. PC Fraser was herself involved in speeding enforcement and her attention was drawn to high vehicle speeds on Kirkintilloch Road leading up to the Garngaber traffic lights (previously reported) and on Crosshill Road at the junction with Victoria Road. Both of these locations were thought to be risk areas whereas other areas might have speeding vehicles but with less likelihood of injury.

4.0 MINUTES OF 15TH AUGUST 2012 MEETING

5.0 MATTERS ARISING

- 5.1 Millersneuk Shopping Centre – following consultations with an EDC Officer, the litter situation had much improved. It is now cleaned twice a week. It appears that EDC had written to owners, pointing out their responsibilities. Potholes and uneven pavements remain as problems for users.
- 5.2 LCC Boundaries – this matter had been raised at the Community Councils Liaison Committee and it had been suggested that Lenzie and Waterside CCs should make a joint recommendation. Secretary had passed map information to Waterside Secretary and Chairman and made a suggestion that the present boundary between Lenzie and Waterside be moved from the Link Road to Calfmuir Road. The meeting concurred with the Secretary’s proposal. Responses from Waterside and EDC were awaited. EDC has agreed to provide a population figure for the current boundary, as we appear to have had no update since the figure of 11,000 in the 1999 Community Councils Establishment scheme.

5.4 Planning item 7.2 – Planning Officer had been contacted concerning the attribution of comments/objections on Applications and had taken note of the point that comments on behalf of the Community Council should be attributed as such rather than to a particular Council member. He also confirmed that the points raised were not treated as ‘objections’ and had been discussed with the Applicant.
